

I was disappointed when I started reading it and realized that there was a series before this book that had more back story to the characters. While I was still able to follow the story pretty well, I still would have liked to have that extra information about the characters. Lilly is the town doctor in a small town in Kentucky. With her husband away on mining business, Lilly finds herself keeping busy with her visiting sister, several patients, and her good friend Armina. Last year, a friend was kind enough to lend me *Skip Rock Shallows* and I really enjoyed that story. When I saw that *Tattler's Branch* was more of Lilly's story, I jumped at the chance to review it. This book was a real page turner. Although it was over 300 pages, I finished it in two days because I was so eager to see what happened. It combined personal struggles and medical as well as murder mystery. Yes, this book kept me turning pages. I have to

admit, though, I really found myself liking Lilly less in this book. She has secrets, and her husband was far from home. I could say more about it, but I don't want to give away any of the book. However, the secrets and the absence of Tern detracted from the book in my opinion. The setting of the book still has the same, strong historical backdrop. While I enjoyed this book, I did not enjoy it as much as the first of the series, Skip Rock Shallows. This book takes place a couple of years after the first and can be read independent of the first (there is enough background). The main character is still Dr. Lily Corbitt in a small coal mining town in Kentucky. The suspense centers around a baby that Lily's friend, Armina, has brought home and a possible crime that her friend witnesses but does not remember what she saw or the baby. There is also a man that is spying on the doctor as well. There is more suspense in this book but the whole book is at a much slower pace and I found myself not being as engaged. (The first book, I did not want to put down most of the time.) I also felt that I wanted more detail. I still enjoyed the setting and the overall premise but it just didn't deliver as smoothly as the first.
